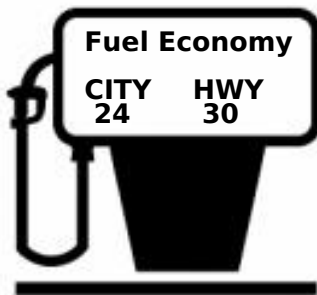

- Frame-cracks, corrective welds, or rusted through
- Dog tracks-bent or twisted frame

Engine

- Oil leakage, excluding normal seepage

- Knocks or misses related to camshaft lifters and push rods
