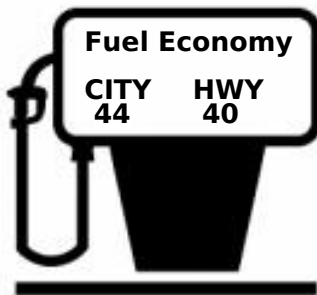

- Knocks or misses related to camshaft lifters and push rods
- Abnormal exhaust discharge
