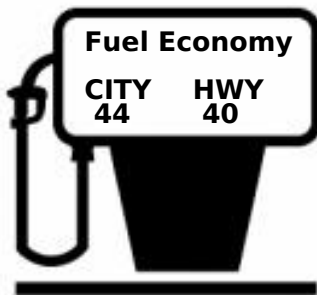

- Improper shifting or functioning of any gear
