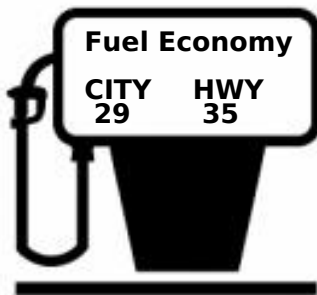

- Frame-cracks, corrective welds, or rusted through

- Knocks or misses related to camshaft lifters and push rods
- Abnormal exhaust discharge
