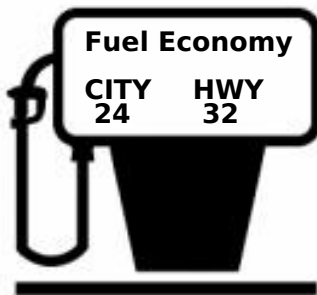

- Improper fluid level or leakage, excluding normal seepage
- Cracked or damaged case which is visible

- Improper shifting or functioning of any gear
